# Big Figures and Big Figures - St Peter's Financial News

At our Annual Meeting I announced that we are currently transitioning to a new era in the way we manage our finances. Our Treasurer, David Fisher, who has been synonymous with St Peter's finances for well over thirty years, is handing over this overall responsibility while remaining an essential member of our finance team.



David, who has been directly involved in almost every aspect of our financial management for so long, has always done everything with self-effacing consistency, integrity, and good humour. We are enormously grateful for all that he has made possible. Over the next few months we will be setting up a new system, the shape of which is not yet entirely fixed. Suffice to say, we are going to need a team with diverse skills and bags of commitment to take up the range of roles that David has occupied up until now. You can read an edited version of David's final Treasurer's Report on the next page and his financial summary of last year's

actuals and this year's forecast on page 7 (also featured in this year's AGM booklet). You will notice, as you review that summary, that our financial situation is a great deal healthier, in these pandemic times, than you might expect. This is due to an anonymous donation of £100,000 received just before the Annual Meeting. Regular giving by Standing Order; some other very substantial donations and grants; alongside this six-figure gift; have enabled us to keep within sight of our financial commitments in spite of so many losses — lost lettings income, lost fundraising activities and lost giving through the weekly collection plate. We are extraordinarily fortunate to be in this position. The challenge that lies ahead, of course, is to build on that foundation to rebuild financial resilience for the future. On the next pages are some of the ways you can help.

## The Treasurer's Report

The figures on the Incomes and Expenditure chart (page 7) show the day-to-day income and costs of the Church. They do not include income and expenditure on the various restricted funds maintained by the PCC which are detailed in the full accounts available on the Welcome Desk. In respect of the 2020 figures the results were greatly influenced by the pandemic. It is very pleasing to see that planned giving was in line with previous years, however all other income headings were significantly less than anticipated although we did receive some generous donations. Much of our expenditure is fixed whether the Church is open or not. There was a large reduction in wage costs due to the receipt of £10,968 in furlough grants. The resultant loss for the year of £58,466 was offset by the surplus brought forward from the previous year of £25,962 and the PCC agreed to transfer £30,000 from the designated reserve meaning that a final deficit of £2,504 is carried forward to 2021. Turning to the forecast for 2021, when I presented the figures to the PCC a deficit for the year of £95,000 was the result. I stressed that this was more of an estimate than a forecast. It is very difficult to predict income until we know the return to full uptake of the facilities and fundraising capacity. Expenditure is to a large extent fixed and thus easier to predict. Having said all that we have now been informed that we will shortly be in receipt of donations of £100,000 meaning that the final result for the year will show an estimated surplus of £5,000.

# Five ways to help to rebuild financial resilience for the future

## Set up a standing order – with Gift Aid if you are a UK taxpayer

If you are not already part of our planned giving scheme, please do take and fill in a *Planned Giving* leaflet. If you are a UK Taxpayer the value of your giving is increased by a massive 25% if you fill in the Gift Aid declaration.

## Get ready to join the Parish Giving Scheme



For those who are part of our Planned Giving Scheme, we will soon be inviting you to switch to the *Parish Giving Scheme*. This Direct Debit means of giving offers substantial benefits. First, the administration of Gift Aid is completed automatically, and the tax recovered is sent to St Peter's each month. Second, it is possible for participants to choose to increase their giving, once a year, in line with inflation. Third, it makes it much simpler for us to thank you for your giving and to provide you with the figures necessary for the Gift Aid notification on your tax return. Your help in making this switch, when it comes, will be enormously helpful and beneficial.

## **Contactless Giving**

If you prefer to give each time you join us for worship, then it is always possible to place cash in the Donations Box by St Mary's Chapel. A cleaner, more efficient option, however, is to use the contactless giving machine on the Welcome Desk.

#### Leave a Legacy

Once you have made provision for your loved ones, you may have the opportunity to leave a legacy in your Will. A gift in your Will is one of the most valuable and lasting ways you can continue to support St Peter's. This type of gift has, again and again, been crucial to enabling St Peter's to thrive in its life of service and mission. For example, it was a legacy that provided the seed that blossomed into the transformative building work completed in 2012.

# Chris Clayton's future at St Peter's

As I announced at our AGM, Chris Clayton's Curacy would, under normal circumstances, now be drawing to a close. Thankfully, however, a combination of factors allows the option for Chris to stay on for up to four more years. First, we have the promise of a gift of £150,000 to help cover the cost of an extra full-time stipendiary priest - Curates in training come at no financial cost to the training parish, once Chris becomes Associate Vicar, however, this will no longer



be the case. Second, the Bishop of Ripon has agreed to the appointment – she will formally license him at a service in St Peter's in June 2022. Third, Chris and Sam are willing to stay! This is, of course, absolutely excellent news. Chris has been an exceptional colleague and we look forward to his developing ministry among us.

## What is the Vicar doing in June?

As I explained at our AGM at the end of May, I will be taking a back seat during June leaving Chris Clayton to take on, in collaboration with the Churchwardens, the day-to-day leadership of St Peter's. This is not primarily about Chris' transition, over the coming year, from Curate to Associate Vicar, although it happily fits that trajectory. My aim is to use weekdays during this month for research – joining in with worship at St Peter's on Sundays. My current projects include preparing for a debate at the Annual Meeting of the Society of Biblical Literature in San Antonio, Texas. The subject being debated is whether Matthew's Gospel copied from Luke's Gospel – a previously underexplored solution to so-called 'Synoptic Problem'. I am also writing a book about the rediscovery of two texts mentioned in the New Testament, but which have long since become lost: the Apostolic Decree written by James the brother of Jesus and the Jerusalem Apostles in AD48 and a missing text written by the author of 1, 2 and 3 John.
